LAST TWO WILDCARDS ANNOUNCED FOR COMERICA BANK CHALLENGER

The USTA announced today that Americans Chase Buchanan and Daniel Kosakowski have received main draw wild cards into the 2010 Comerica Bank Challenger, a

\$75,000 USTA Pro Circuit event to be held at the Seascape Sports Club from July 12-18. Together with today's qualifying results in singles, this completes the main draw roster for the event.

Like the other two wildcards in the tournament this year, these two are young up and coming champions, just breaking into the pro circuit.

Buchanan is 19 years old, and competed in the 2009 Open singles after earning a wildcard spot. He won the USTA Boys' 18's National championships in Kalamazoo, Michigan that year, where he was the #2 seed. He joined the Ohio State team as a freshman in spring, 2008, as the #1 ranked player in the nation in Collegiate Tennis. In international men's tennis, he has a ranking of 1319.

Kosakowski, at age 18, is a recent graduate from Warren High School in Downey, California, has had an outstanding year in Boys' 18 tennis. After winning the USTA National Winter Championship, he entered the USTA International Spring Championship as a wildcard, and brought home that title too. He has a ranking of 1375 in men's tennis.

Tomorrow, July 11, will complete the qualifying event, with doubles matches beginning at 9:00 a.m.

Matches will take place throughout the day, beginning at 9:00 a.m., with feature matches beginning at 5:30 p.m. each week night. Barbecue lunch is available on the lawn. Kids age 6 – 12 are half price, age 5 and under free.
