**No. 1 seed Daniel Evans Headlines First Day of The Nordic Naturals Challenger
presented by Santa Cruz County Bank**

Set on center stage at 6 p.m. Monday, Aug. 8, No. 80 Daniel Evans faces 20-year-old Tom Fawcett in the first main draw feature match of the Nordic Naturals Challenger presented by Santa Cruz County Bank.

2013 Aptos Finalist, Evans returns to Seascape this year as the No. 1 seed. Great Britain's Evans, 26, is hitting his stride this season with imposing victories over players including No. 34 Grigor Dimitrov, No. 38 Alexandr Dolgoplov, No. 89 Ricardas Berankis, No. 74 John Millman and many more top-ranked competitors. He reached a ranking high of No. 74 last month.

Making his imprint on the college scene is freshman and No. 1 Stanford player American Tom Fawcett. Fawcett was proclaimed the Pac-12 Freshman of the Year after posting a 14-7 singles record at the No. 1 position. The 20-year-old finished the 2015 season at

No. 35 in the ITA rankings. Since 2015, Fawcett has appeared in several Challenger events. Aptos is a chance for him to carry over his recent success as a top-tier college competitor into the ATP tour.

This exciting feature matchup is just one of many to be help at Seascapes Sports Club this week. On Tuesday an all-American match will also be featured on centered court at 6 p.m. when No. 115 Bjorn Fratangelo takes on No. 290 Alex Kuznetsov.
